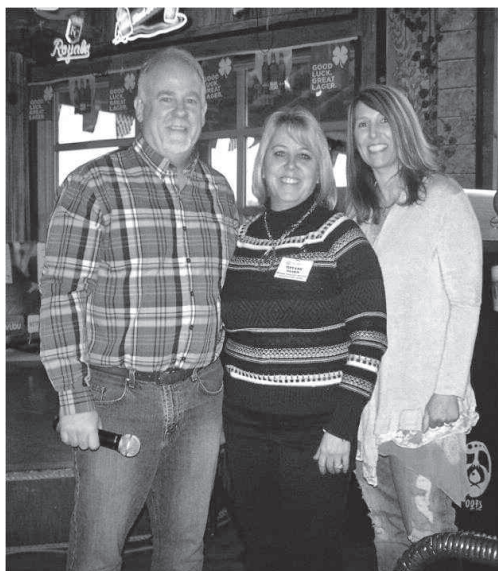


March was an extremely busy month for the Lake West Chamber. We are pleased to announce all three of our major events were very successful.
